3.	Clinical Program Review 3.1) Home Based Services/Infant Mental Health, K. Maciag	3.1) K. Maciag reviewed the home-based services/infant mental health program noting staffing and the increasing trend of emotional and behavioral issues with younger children. In addition, childcare has been a reported issue amongst families. BABH recently secured a grant for Infant Early Childhood Mental Health Consultation (IECMHC) from the MI Department of Health and Human Services (MDHHS). This is an evidence-based practice that focuses on children in childcare settings to prevent future adjustment or transition issues to pre-school and kindergarten. There were discussions related to the terms of the grant and the required local match, the increase of autism services, any correlation with increased behavioral issues amongst the child population, and that this is an evidenced based program.	3.1) No action was necessary

6.	New Business 6.1) Alternative Order for Treatment (AOT) – Grant Application, J. Hahn	6.1) J. Hahn reported Kevin's Law established a process for petitioning an individual for outpatient treatment even if they have not been previously hospitalized for mental health reasons. The law was revised and now alternative order for treatments (AOTs) are utilized in lieu of a full petition for psychiatric hospitalization. BABH has a grant position that monitors court orders and will now be tracking the AOTs as well. The AOTs also tie to the Red Flag Laws, which allows the public to challenge firearm ownership of individuals with mental health disorders on a short-term basis. BABH does collaborate with local judges for court orders.	6.1) No action was necessary
