

1.	Call To Order & Roll Call	Committee Chair, P. McFarland, called the meeting to order at 5:00 pm. All members were present.

Prusi reviewed the report noting the number of complaints filed, the average days to resolve complaints, source of complaints, substantiation rates, remedial action, trainings, and site visits. There were discussions regarding staff filing complaints, targets for substantiated rates, evidence requirements for substantiating a complaint, and examples of abuse class II categories. 4.2) M. Prusi reviewed the training noting requirements of a comprehensive exam being completed. 4.3) M. McFarland, reported the site visits are included and a per diem is provided. Interested members interested in attending should coordinate with S. McRae.</p> <p>4.5) Committee Chair, P. McFarland, reported the annual Recipient Rights training needs to be completed.</p> <p>4.6) C. Pinter reviewed the MLive article claiming the Rights process is not effective. The reported did reach out to BABH prior to publishing the article. BABH did not comment and referred the reporter to the State Office of Recipient Rights. C. Pinter also reviewed the data from BABH regarding 2023 and 2024 abuse and neglect complaints. BABH has significantly higher substantiation rates than the state average. M. Prusi reported community mental health (CMH) agencies do not have jurisdiction over the Recipient Rights system in state inpatient hospitals but, were required to conduct the Recipient Rights system assessment which included policy reviews and on-site review for the necessary standards. However, the lack of authority over the inpatient hospitals and response to correct the assessments citations led to the MDHHS ORR to take over the RR system assessments. The Rights system originated from a hospital-based system, which is why there are policies such as requiring an assessment to be performed or that CMHs cannot pull teeth or sterilize individuals.
